Official Contest Rules 2010


- 1. Term** All 2010 Capture Juneau Photo Contest photographs must be taken between May 4, 2010, and September 28, 2010. Photographic submissions must be posted no later than October 31st, 2010. By submitting a photo, each entrant agrees to the Official Contest Rules and warrants that his or her entry complies with all requirements set out in the Official Contest Rules. Submissions may be posted at any time during the entry period.
- 2. Who May Enter** The contest is limited to all guests who have taken any one of the following Gastineau Guiding Company (GGC) tours in 2010:

 - Alaska's Whales & Rainforest Trails
 - Capture Juneau Photo Tour

- 3. How to Enter** To enter, visit www.StepIntoAlaska.com/PhotoContest.cfm
- a. Follow the directions on our website to open a Picasa account and post a Picasa Web Album. Picasa is free photo editing software from Google. Together, Picasa & Picasa Web Albums make it easy for you to organize and edit your digital photos, then create online albums to share with friends, family and the world.
 - b. All photographs entered in the contest must be submitted online, posted as a "Public" Web Album and "tagged" ONLY with the following:
 - Gastineau Guiding Company
 - 2010 Capture Juneau Photo Contest
 - The full name of the Gastineau Guiding Company tour you were on (see tour names above)
 - The entrant's full name
 - Subject of the image
 - c. All photographic submissions must be taken while on tour with Gastineau Guiding Company. Appropriate subjects for entry are:

Pictures that connect people to the place. Show us the highlights of your Juneau experience.



From landscapes, panoramas, and macros to seascapes, glacial images, and wildflowers. Let your imagination be your guide.

 Each entrant may submit up to 3 photographs. Photos may be in color or black and white. Photos submitted with recognizable people must be limited to those participants traveling on tour (Each participant signs a model release at the beginning of the tour).
- 4. Contest Prizes** A third place prize, a runner-up prize and a grand prize will be awarded. Limit one prize per entrant. The 3 prizes are as follows: Grand prize = \$500.00 USD, Runner-up prize = \$250.00 USD, Third place prize = A Fuji Film Finepix Z33 Water Proof Digital Zoom Camera (Donated by Art Sutch Photography, Juneau's local camera shop, located at 221 Seward St, in downtown Juneau)
 Potential winners are required to sign and return within ten (10) days, a W-9 IRS Form for tax purposes. Failure to execute and deliver any required documents to GGC by the specified deadline may result in disqualification from the contest, and selection of an alternate potential winner.

Judging** GGC will judge collective submissions and select a grand prize winner, a runner-up and a third place award based on the following criteria: (1) Creativity; (2) Photographic quality; and (3) Representation of the tour experience. All winners will be chosen by November 30, 2010, and notified by phone, mail and/or e-mail on December 1, 2010. Decisions of GGC are final and binding.
